## NISSAN eRecruiting COOKIES policy

This Cookie Policy is intended to inform you how Nissan uses a technology called “cookies” and web server logs, to assist you in making informed decisions when using our site.

### WHAT ARE COOKIES?

Cookies are small text files that are placed on your computer or mobile phone browser by websites that you visit. Cookies are widely used in order to make websites work, or to improve the user experience, as well as to provide certain information to the owners of the website.

Our cookies may include information about your online preferences and allow us to tailor our eRecruiting website (the “Site”) to your interests, and often include an anonymous unique identifier.

### CONSENT TO USE OF COOKIES ON eRecruiting

By continuing to use our Site, you are deemed to consent to our use of the cookies described in this policy. If you do not consent to our use of cookies, then please read the next section “Blocking Use of Cookies”.

### BLOCKING USE OF COOKIES

You have the opportunity to set your devices to accept all cookies, to notify you when a cookie is issued, or not to receive cookies at any time. The last of these options means that certain personalized services cannot then be provided to you, which may result in you not being able to take full advantage of all of the features of our Site.

If you do not wish to receive cookies generally, or to object to certain cookies, you might need to change your browser settings. However, each browser is different, so please check the “Help” menu of your preferred browser to learn how to change your cookie preferences. If you choose to block use of cookies, some aspects of the site may not work properly and you may not be able to access all or part of our site.

## **HOW DO WE USE COOKIES?**

Information supplied by cookies can help us to analyse your use of our Site and help us to provide you with a better online user experience.

The information our cookies collect is not used to identify who you are, or to send you advertising by e-mail or post. Further, we do not use cookies to provide targeted and personalized advertising.

## **WHAT TYPE OF COOKIES DO WE USE FOR WHAT PURPOSES?**

### **TECHNICALLY REQUIRED COOKIES**

Some of our cookies are strictly necessary to use our Site or certain functionalities within them. If you block these functional cookies, you cannot use our site. This includes the cookies to register whether the user has consented to cookies being used by our Site or not.

### **SESSION COOKIES AND PREFERENCE COOKIES**

We might use session cookies to uniquely identify your browsing session on our site, to facilitate the functioning of our Site, such as to enable the user to navigate through the different pages. These cookies expire at the end of the user session (e.g., when the user closes the browser window). We might also use cookies that persist for a longer period in order to remember your preferences and choices on our Site. Generally, those cookies will not have a life span exceeding two years.

### **ANALYTICS COOKIES**

We might use analytics cookies in conjunction with our web server's log files to enhance the performance of our Site by collecting aggregated information about how many visitors we have, where visitors have come to the site from and how they use the Site (e.g. which pages most visitors go to most often). For this purpose, we might use the analytics tools of the following providers and related cookies:

We do not generally store any personal information that you provide to us in a cookie.

## SOCIAL NETWORK COOKIES

We might integrate in our Site features from third party websites, in particular from certain social networks. Those features sometimes come with scripts or other elements that can read, and sometimes place, cookies from those social networks on your device. These cookies might allow the personalisation of advertising, to make advertising more relevant to your interests. We have no access to or control over those cookies or the data collected by those cookies, because we are only the operator of the Site, however we would like to inform you and obtain consent for those elements.
